1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are at  
A Dog's Dream Daycare, LLC.
2. I further understand and agree that in admitting my dog(s) to A Dog's Dream Daycare, the staff has relied on my  
representation that my dog(s) is/are in good health and has/have not harmed or shown aggressive or threatening behavior  
towards any person or any other dog.
3. I further understand and agree that A Dog's Dream Daycare and the staff will not be liable for any problems that develop,  
provided reasonable care and precautions are followed, and I hereby release them of any liability of any kind whatsoever  
arising from my dog's/dogs' attendance and participation at A Dog's Dream Daycare.
4. I further understand that dogs can sometimes receive minor scratches and bumps at daycare and any problems that  
develop will be treated as deemed best by the staff of A Dog's Dream Daycare, at their sole discretion, and that I assume  
full financial responsibility for any and all expenses involved.
5. I further understand that dogs may, without warning, bite or cause injury to humans and other dogs. I acknowledge and  
understand there are certain risks involved in participating in cage-free daycare/boarding/grooming, including but not  
limited to dogfights, dog bites to humans or other dogs and the transmission of disease.
6. In the case of emergency, I recognize the risks of injury that accompany transport and acknowledge that this RELEASE  
is being relied upon by A Dog's Dream Daycare to permit transport of my pet to and from the facility or any other  
necessary location. Furthermore, I accept any and all conditions, rules and regulations associated with the activities,  
use of the facilities and transport, and hereby agree to comply with them.
7. I understand that excessively long toenails may cause injury. If the staff is required to trim them, a fee of \$10 will apply.
8. I understand that regular flea preventatives are required. If fleas are discovered on your dog while at A Dog's Dream  
Daycare, the staff will immediately administer a Capstar tablet. Dogs that are boarding may also receive a dose of their  
regular preventative. The cost for the preventatives will be added to your bill.
9. I understand that water is available at all times; however, my dog may still be thirsty after daycare, grooming, boarding.
10. I understand that any behavior deemed dangerous or inappropriate by staff may result in dismissal from the program.
11. I agree to pay for all services at the time they are rendered. I understand that any unpaid fees will be sent to collections  
and I will be responsible for all collections and legal fees incurred by such actions taken. I further understand that  
A Dog's Dream Daycare may hold my dog(s) until my bill has been paid or payment arrangements have been made.
12. I agree and understand that if my dog(s) is/are left at A Dog's Dream Daycare for 10 days beyond the scheduled pick-up  
date, and I have not made contact with said company, the company will consider the dog(s) abandoned and has the right  
to re-home my dog(s), according to Florida State law.
13. I understand that A Dog's Dream Daycare staff is trained to assess injuries and provide treatment for minor incidents. If  
there is any question about the seriousness of an injury, the dog will be taken to a veterinarian for examination. Owners  
are responsible for any medical fees.

The purpose of A Dog's Dream Daycare is to provide a safe, fun and stimulating social environment for dogs in daycare, boarding, and grooming. To ensure the safety and health of your pet and our other guests, we require all guests to comply with the following rules and regulations:

1. **AGE:** All dogs must be at least 12 weeks of age or older.
2. **SEX:** All dogs six months or older must be spayed or neutered. Sorry, no exceptions.
3. **VACCINATIONS:** All dogs must have up-to-date vaccinations. Owners must submit written proof of distemper/parvo, rabies and bordetella vaccinations.
4. **HEALTH:** All dogs must be in good health. Owners will certify that their dogs are in good health and have not been ill with a communicable condition in the last 30 days. Upon admission, all dogs must be free from any condition that could potentially jeopardize other guests. Dogs that have been ill with a communicable condition during the past 30 days will require veterinarian certification of health to be admitted or readmitted.
5. **FLEAS/TICKS:** Use of regular flea preventatives (topical or oral, NOT flea collars or shampoos) are required. If at any time during care a dog is noticed to have fleas or ticks, treatment will be applied and charged to the owner accordingly. All dogs will be examined for signs of fleas and ticks at check-in and will not be admitted to daycare if fleas or signs of fleas or ticks are noticed.
6. **QUICK RELEASE COLLARS:** Required with nametags. **NO METAL, CHOKE OR FLEA/TICK COLLARS.**
7. **FOOD:** All food brought to the facility must be labeled with your dog's name and stored in airtight/bug-proof containers. If food is brought without a container, one will be provided and a fee charged. Open bags are not suitable containers. Owners must provide food for boarding animals.
8. **BEHAVIOR:** All dogs must be non-aggressive and not food or toy protective. Owners will certify that their dogs have not harmed or shown any aggressive or threatening behavior towards any person or any other dog(s). All dogs must pass a behavior assessment for enrollment. Keep in mind that although it is supervised play, your dog still might acquire an occasional nip, scratch or other minor injury. It is comparable to children playing at the playground; occasionally one will bumped or scraped.
9. **ENROLLMENT:** All dogs must have a complete up-to-date and approved contract on file. Please note that dogs that attend daycare regularly tend to enjoy the routine and have more fun because they are familiar with all the other dogs and staff members. We require attendance of at least one day per week when owners are in town.
10. **FEES:** Daycare fees are payable at the end of each day unless a multiple-day pass is purchased. Cash or Mastercard/Visa are accepted. We are able to accommodate most special needs requests (i.e. medication administration, etc.) at no charge, but some may require fees.
11. **HOURS OF OPERATION:** Hours are Monday through Friday, 7-11:30 a.m. and 1:30-7 p.m., and Saturdays, 9 a.m. to noon, and Sundays for pick up/drop off only 9-11 a.m. Pick up after hours and on holidays is available by appointment for an additional \$75.00 fee. If you make an appointment and don't show up, you will be liable for this fee anyway.
12. **RESERVATIONS:** We do prefer reservations for daycare in advance but usually can accommodate dogs without reservations. Reservations are required for boarding and grooming. Cancellations for boarding or grooming with less than 72-hour notice will be charged full fees. A non-refundable down payment is required at the time of reservation for boarding.
